TO WHOM AND FOR WHAT PURPOSES WILL THE CONTROLLER BE ABLE TO TRANSFER YOUR PERSONAL DATA?

Within the scope of the healthy functioning of our analytical activities, your personal data and the encrypted ID associated with this data are anonymized and transferred to other third parties in a way that does not allow you to be identified.

In short, your personal data is not shared with any third party.

COOKIE MANAGEMENT

Depending on the type of Internet browser you have, you can exercise your right to know about cookies and allow or reject cookies by following these steps:

TYPES OF COOKIES

Types of cookies according to the duration of use: The Web site operated by the Data Controller uses session cookies and persistent cookies according to the duration of use. The session cookie expires when you close the Web site. A persistent cookie remains on your hard drive for a long time or indefinitely.

Types of cookies according to the owner of the cookie or the party placing the cookie: In the Web site operated by the Data Controller, "first party cookies" and "third party cookies" are used according to the placing party. Data Controller cookies are created by the Data Controller, while third-party cookies are managed by third-party companies with whom we cooperate. The information collected within the scope of the third-party cookies used is transferred.

Types of cookies according to the purposes of use: According to the purpose of use in the Web site operated by the Data Controller; technical cookies, verification cookies, targeting/advertising cookies, personalization cookies and analytical cookies are used. The Data Controller uses these cookies; It conducts analytical studies by determining the features that distinguish its users from each other.

Session Cookies	Session cookies are temporary cookies used during our visitors' visit to the Web site and are deleted after closing the Web site. The main purpose of using such cookies is to ensure the proper functioning of the Web site during your visit.			
Persistent Cookies	Persistent cookies are types of cookies used to increase the functionality of the web site and to provide a faster and better service to our visitors. Such cookies are used to remember visitor preferences and are stored on the device used via browsers.			
Technical Cookies	With technical cookies, the operation of the Web site is ensured and non-working pages and areas are detected.			
Authentication Cookies	If Users log in to the Web site using their passwords, such cookies will determine that the User is an web site user on each page visited by the User, preventing the User from re-entering his password on each page.			
Personalization Cookies	They are cookies used to remember the preferences of users when visiting different Web site pages.			
Analytics Cookies	Analytical cookies are cookies that provide the production of analytical results such as the number of visitors to the Web site, the detection of the pages displayed in the Web site, the hours of the Web site visit, the location of the Web site visit, the scrolling movements of the Web site pages.
